Domestic Students Applying for Federal Student Aid Only:

Returning International Students:

- Your initial application filed prior to enrolling will be used to renew 24-25 Colgate Grant.

2024/2025

- Returning student financial aid notices are being emailed continually to those who submitted all aid application requirements.
- Newly enrolling students will be given access to view their Financial Aid Summary around June 15th.
- All aid applicants should check "Documents & Messages" regularly for confirmation of receipt of aid application requirements.

Fill in all 3 fields with your outside resource information and click "Save and Submit". The Office of Financial Aid will receive your outside resource information and account for it within your aid package. If any changes to your aid package result, you will be notified via e-mail. If you need to report additional outside resources, complete another "Outside Resource" form and submit it.



**Outside Resource #1 Form- Award Year 2024/2025**

You are required to report all scholarships and educational resources you receive from agencies outside of Colgate University. Examples of outside resources you must report include scholarships or grants from community organizations, agencies, or companies; tuition benefits from your employer or your parent's employer, resources awarded outside of Colgate University for any educational cost (books, supplies, travel to campus, tuition, room & board, etc.). You do not need to report Federal or NY State awards (e.g. Pell Grants, Federal TAP or NY Merit).

If you receive multiple outside resources, report them one at a time, each on a separate form (after submitting the first form, subsequent forms will be made available on your portal). For any questions, contact the [Office of Financial Aid](#).
